In Consideration of receiving permission to enter events locations from government authorities and/or private land holders, the undersigning/ participant (hereinafter called the participant), herein releases, discharges and forever acquits MTBA, government authorities and/or landholder collectively and all respective officers, directors, servants, employees and agents of, from any and all liability claims, demands, warranty, weather expressed or implied of MTBA, government authorities and/or landholders and their respective officers, directors, servants, employees and agents, while on the locations and/or participating in the aforementioned activity.

This liability release shall be binding upon the assignee, distributes, heirs, next if kin, executors, and administrators of the undersigned and may be pled by MTBA, government authorities and/ or landholders as a complete bar against defense against claim. Demand, action by or on behalf of the undersigned.

By execution of the liability release, the participant acknowledges and expressly represents that:

1. I understand that HELMETS ARE COMPULSORY and agree to wear a helmet at all times.
2. Downhill Participants must have a FULL FACE ONE PIECE HELMET to be worn at all times of the event.
3. The Participant is duly aware of the risks and hazards inherent upon entering the event location which the participant does voluntarily
4. The participant assumes the duty of knowing the present conditions of the location, these conditions may change during the course of the event and it remains the duty of the participant to adjust riding technique to compensate.
5. Participants recognizes falls and collisions with pedestrians/ other riders and vehicles do occur and assumes all risks and responsibility for such incidents and injuries.
6. Participant is over 18 yrs old and is of sound mind, or that if he/she is under 18 yrs old, he/she is accompanied by a parent or guardian who is over 18yrs old and of sound mind who has read the forgoing release, understands it and signs it voluntarily. Furthermore the undersigned being at least 18yrs old indemnifies the aforementioned entitles against any and all claims, which may result from the minor's participation in the aforementioned activity.

In exchange for and in all consideration if the above named parties making the event locations available to me, participant contractually agrees that any and all disputes between myself and the above mentioned parties arising from my participation in the events and including any claims for personal injury and /or death, will be governed by the laws of the state and exclusive jurisdiction thereof will be in the state court residing in the district where the alleged tort occurred.
8. This release shall be binding to the fullest extent of the law. In the event any section of the releases is found to be unenforceable, the remaining terms shall be enforceable.
